





Based on the Assessor's Report, it has been decided not to grant recognition to the above mentioned qualification as the college/ institute has the following deficiencies, which are in contravention of the norms stipulated in the Post Graduate Medical Education Regulation-2000 (PGMER-2000):

- i. *Immunohistochemistry is not available in the department, it is outsourced;*
- ii. *ICD-X classification is not used;*
- iii. *HPLC for Haemoglobinopathy is not available in department. The facility is outsourced;*
- iv. *Autopsy (Pathological- Adult fetal) is nil;*
- v. *Central Research Facility: most of the equipments are not for Pathology; and*
- vi. *Departmental Research Facility/Lab: all equipments are old and almost non-functional.*

2. Therefore, the college/institute is required to submit a written explanation to the PGMEB of NMC within 30 days from the date of the issue of this letter with supporting documents. The compliance report should be submitted to the PGMEB of NMC along with the requisite fee of Rs.1,18,000/- (which includes 18% of GST) by RTGS/ NEFT (the details of fee i.e. UTR No. and date should be provided along with the compliance being submitted by you). In case, no compliance is received within the stipulated period or compliance is found unsatisfactory, it will result in stoppage of admission in terms of Regulation 6(2) and 6(3) of PGMER-2000.

3. Please also note that compliance/ compliance verification report should be submitted only in the SAF prescribed for this purpose (available on NMC website, i.e. www.nmc.org.in), which should also include the faculty table (entire faculty including those who has already been verified). Information in any other format will not be accepted.
